

Basic description

The 3M 5000 series models are the particle filtering element used with the components detailed below to form particle only filter assemblies or combined filter assemblies. All filter assemblies thus formed must be used as matched pairs. Within the range one model has a name only variant for the Automotive Refinish Industry.
